Fund objective

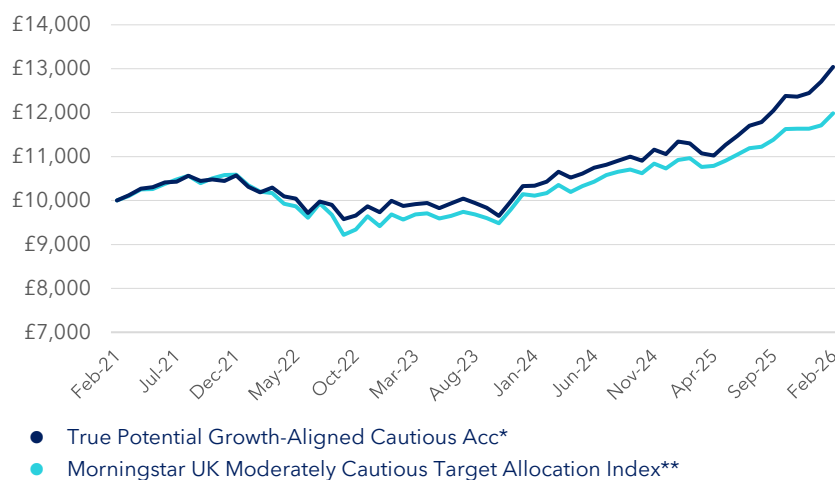
The Fund aims to achieve growth over the long term (5 years or longer).

February Update

Global equities delivered further gains in February as value style shares significantly outperformed their growth style peers. Emerging Market (EM) equities outpaced their developed market counterparts despite weakness in China. In developed markets, Japanese shares led the gains, while US equities proved a laggard. In fixed income, long-dated UK Gilts outperformed amid lower yields. Elsewhere, gold delivered solid gains.

The True Potential Growth-Aligned Cautious Fund returned 2.61% (net of fees). The Fund's large allocation to equities was advantageous over the month, further supported by strong performance from most of the active managers. A sizeable exposure to Japanese, EM and UK shares proved particularly beneficial as they significantly outpaced the broader market. The Fund's exposure to global value style shares via the Xtrackers MSCI World Value UCITS ETF also notably contributed as they outperformed global equities. Meanwhile, the underexposure to US shares was also beneficial as the region significantly lagged the broader market. In fixed income, the allocation to long-dated UK Gilts and US Treasuries drove performance, while the allocation to EM debt via the L&G EM Government Bond LC Index Fund was also supportive. Conversely, the Fund's tilt towards high-yield bonds within the corporate credit segment was modestly unfavourable as the Amundi Core EUR HY (hedged to sterling) delivered modest gains yet lagged sovereign bonds. Gold provided a notable contribution, while a smaller allocation to the AQR Managed Futures Fund (hedged to sterling) produced gains in absolute terms.

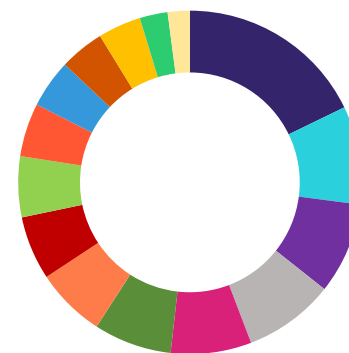
What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.54%. This means that if you invest £1000 in the fund, you can expect to pay £5.40 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
