Fund objective

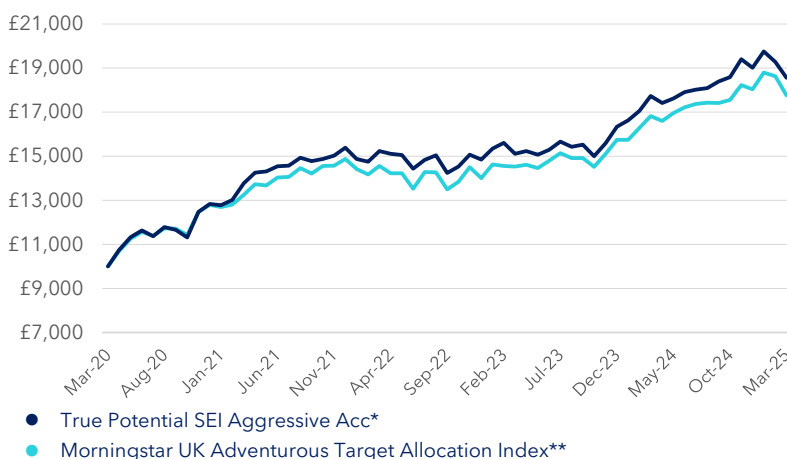
The Fund aims to provide growth by investing predominantly in other investment funds which have a global equity focus.

March Update

Developed market shares posted steep declines, mainly due to the imposition of Trump's tariffs on autos, steel and aluminium, and the expectation of a broader tariff announcement in early April. US equities fared the worst against the backdrop of rising stagflation concerns. Emerging Market (EM) equities outperformed, supported by fresh stimulus measures in China. In fixed income, US Treasuries outpaced UK Gilts and German Bunds, with global credit and high-yield bonds posting losses. Elsewhere, gold rallied as investors sought safe-haven assets.

The True Potential SEI Aggressive Fund declined 3.77% (net of fees). In a weak month for developed-market equities, the Fund's allocation to the asset class was negative. All the allocations to index funds that track global equity factors delivered negative returns, with the 'momentum' factor faring the worst. Conversely, the 'value' and 'quality' factors also declined in absolute terms, but still outpaced global equities. The Fund's allocation to EM equities via the SEI Emerging Markets Equity Fund also hindered relative returns but outperformed the broader asset class. Conversely, the Fund's US dollar exposure was a detractor in a strong month for sterling.

What are the fees associated with investing in this fund?

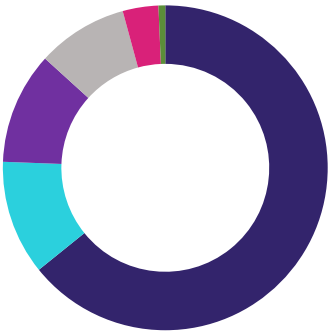
The OCF of this fund is currently 0.96%. This means that if you invest £1000 in the fund, you can expect to pay £9.60 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
