### Objective and Investment Policy

The Fund aims to provide a total return, mostly by income but also with some growth.

The investments in the Fund are mostly passive (tracks the performance of a stock index or another type of investment), but the investment manager makes active decisions on the mix of assets in their Fund.

Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The Fund will invest predominantly, directly or indirectly, in:

- Bonds (issued by governments and other organisations)
- Shares (unit of ownership in a company)

The Fund may also invest, directly or indirectly, in: Other investment funds, cash, deposits, money market instruments (investments usually issued by banks or governments that are a short-term loan to the issuer by the buyer), derivatives, hedge funds, private equities (indirectly), property (indirectly), commodities (indirectly).

There are no geographical restrictions on the countries of investment.

The Fund may use derivatives (a financial instrument whose price is dependent upon or derived from one or more underlying assets) for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital. The Fund may also use derivatives for investment purposes.

You can buy and sell shares on any working day in London, excluding UK public and bank holidays.

The Benchmark for this fund is Morningstar UK Moderately Cautious Target Allocation, this is a Comparator Benchmark. The Benchmark may be used as a guide to compare and assess the performance of the Fund. Our aim is to help you monitor how your investment is performing. The Manager believes this is an appropriate comparator benchmark, given the multi-asset nature and relative risk profile of the Fund. The Fund does not use the benchmark as a target, nor is the Fund constrained by it. The mix of assets in the Fund may vary from those of the benchmark (and its constituents). 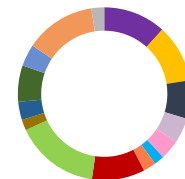

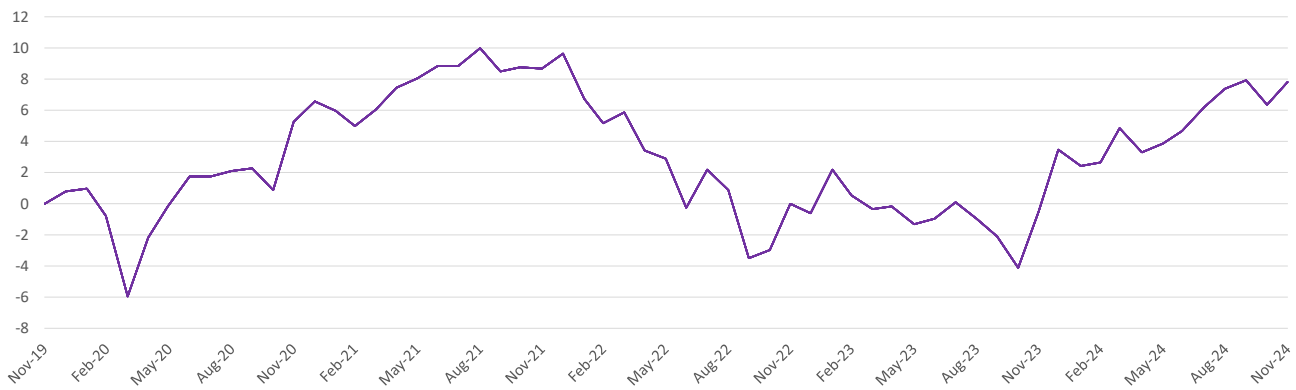
