Objective and Investment Policy

The Fund aims to achieve growth over the long term (5 years or longer) through active management of a diversified investment portfolio whilst seeking to control the overall level of portfolio risk.

Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 5 years.

To reflect the aggressive nature of the Fund, 40% to 100% of the Fund will be invested in assets which are considered higher risk. Higher risk assets include domestic and international equities, property, commodities and absolute return strategies. Exposure to these assets will be achieved indirectly through collective investment schemes (this may include collective investment schemes manager or sub-investment manager), listed securities and derivatives.

The Fund may also invest directly or indirectly in: Bonds (issued by governments and other organisations), cash, deposits and money market instruments (investments usually issued by banks or governments that are a short-term loan to the issuer by the buyer).


