December Investment Manager commentary

Major stock markets ended the year on a negative note, weighed down by a stronger US dollar and weakened expectations for further interest-rate cuts in the US. The Federal Reserve cut rates by 0.25% but raised inflation forecasts for 2025. Government bonds struggled due to rising US Treasury yields and political instability in Europe. Gold prices fell, and a short-lived oil rally was impacted by weakening global demand.

The True Potential Allianz Balanced fund fell 0.69% (net of fees) in December. The fund's allocation to global equities, including Japan, Europe and emerging markets (EMs), proved supportive. A smaller allocation to the US equity segment versus peers boosted relative returns as US shares proved a laggard over the month, dragged down by stretched valuations and revised interest-rate expectations by the Fed. The overweight to Japanese equities was also beneficial as shares rose, helped by a weaker yen. Within the fixed income segment, the fund was broadly neutral duration relative to its peers. The allocation to UK gilts detracted but the negative effect was partially offset by the fund's exposure to Chinese bonds. Elsewhere, the allocation to gold proved detrimental against the backdrop of a strengthening US dollar. More positively, the exposure to commodities provided some cushion, with the Allianz Dynamic Commodities Fund posting a modest positive return for the month.
