## **True Potential Pictet Aggressive**

### **Fund objective**

The Sub-Fund seeks to deliver growth over a rolling 3 year period net of fees.

### **December Investment Manager commentary**

Major stock markets ended the year on a negative note, weighed down by a stronger US dollar and weakened expectations for further interest-rate cuts in the US. The Federal Reserve cut rates by 0.25% but raised inflation forecasts for 2025. Government bonds struggled due to rising US Treasury yields and political instability in Europe. Gold prices fell, and a short-lived oil rally was impacted by weakening global demand.

The True Potential Pictet Aggressive fund fell 2.77% (net of fees) in December. The allocation to thematic equity funds detracted from performance, with the overweights in the digital and security themes faring the worst as US stocks fell. Tactical allocations to interest-rate-sensitive US utilities and financials stocks also performed poorly. In contrast, Japanese and Asian equities provided positive contributions to relative performance, both delivering gains in absolute terms. In fixed income, the fund's allocations to Emerging Market local-currency bonds detracted the most. In alternatives, the holding in a broad commodity index fund performed well, but the allocation to gold detracted. The fund hedging the US dollar back to sterling detracted as the former strengthened over the period in review.
