

# True Potential SEI Defensive

## Fund objective

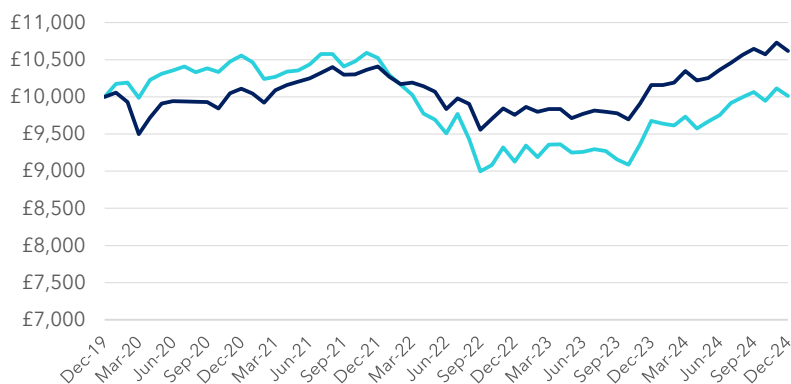
The Fund aims to protect against the risk of a significant loss of capital and to provide some growth and income growth by investing in other investment funds which have an equity and fixed income focus.

## December Investment Manager commentary

Major stock markets ended the year on a negative note, weighed down by a stronger US dollar and weakened expectations for further interest-rate cuts in the US. The Federal Reserve cut rates by 0.25% but raised inflation forecasts for 2025. Government bonds struggled due to rising US Treasury yields and political instability in Europe. Gold prices fell, and a short-lived oil rally was impacted by weakening global demand.

The True Potential SEI Defensive fund fell 1.05% (net of fees) in December. The allocation to index funds that track global equity factors delivered negative returns, with the 'minimum volatility', 'momentum' and 'value' factors faring the worst. In fixed income, the fund's allocation to UK gilts detracted the most as yields rose. In contrast, a large global core bonds segment performed better, with short-dated sovereigns delivering positive returns. Elsewhere, the allocation to the SEI Liquid Alternatives Fund delivered flat returns, outperforming both equities and bonds.

## What is the benchmark for this fund?

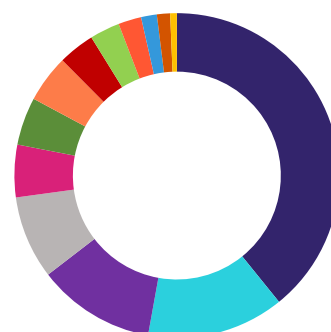
## What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.86%. This means that if you invest £1000 in the fund, you can expect to pay £8.60 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
<b>Investment Fund Risk</b>	This Fund invests into other investment funds, they may invest in different assets, countries or economic sectors and therefore have different risk profiles not in line with those of this Fund.
