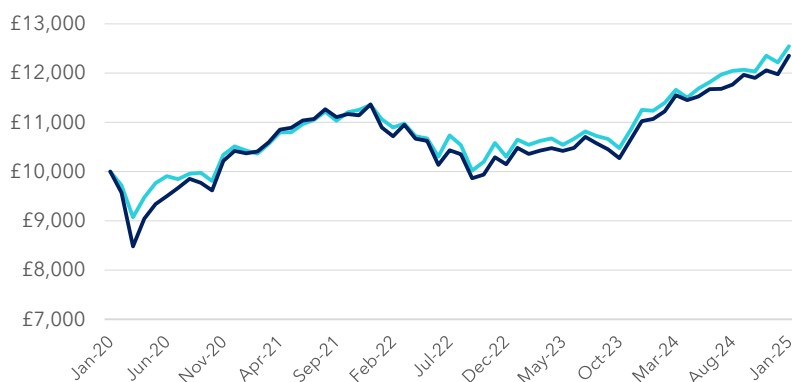

January Investment Manager commentary

Major stock markets began the year strong. European and UK equities outperformed, driven by a better eurozone outlook and a weaker US dollar. US Treasury yields spiked due to higher inflation expectations from President Trump's policies (including tariffs and tax cuts), but later eased, with sovereign bonds showing modest returns. Elsewhere, gold prices rose.

The True Potential Allianz Balanced Fund returned 3.15% (net of fees). The fund's higher allocation to European equities versus peers proved beneficial; European shares outperformed their global counterparts, supported by an improving economic backdrop that fueled a rally in financials and consumer stocks. The fund's higher exposure to Japanese and emerging market (EM) equities hurt performance, as Japanese shares slightly rose but lagged global peers, weighed down by a stronger yen. Meanwhile, EM equities also struggled, mostly due to the ongoing threat of Trump's tariffs and profit taking in Indian shares. Within the fixed income segment, the fund's preference for core government bonds over corporate credit was unfavourable as the former produced lacklustre returns over the month, dragged down by a spike in yields during the first two weeks of January. In contrast, a riskier global high-yield segment fared better, supported by tightening spreads. Meanwhile, EM bonds posted the strongest gains within the fixed income segment, mostly helped by a weaker US dollar. Elsewhere, the allocation to gold and commodities also added value, with the Allianz Dynamic Commodities Fund delivering strong gains for the month.

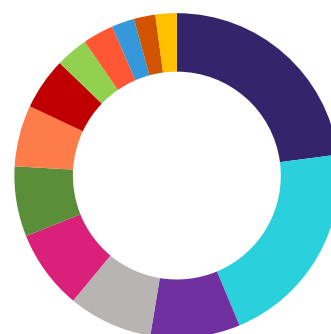
What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.78%. This means that if you invest £1000 in the fund, you can expect to pay £7.80 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
