January Investment Manager commentary

Major stock markets began the year strong. European and UK equities outperformed, driven by a better eurozone outlook and a weaker US dollar. US Treasury yields spiked due to higher inflation expectations from President Trump's policies (including tariffs and tax cuts), but later eased, with sovereign bonds showing modest returns. Elsewhere, gold prices rose.

The True Potential Growth-Aligned Balanced Fund returned 3.19% (net of fees). The fund's overweights to European and UK equities proved beneficial as shares in both regions significantly outpaced their global counterparts. European shares posted the best returns overall as positive indicators in the eurozone economy fuelled a rally in financials and consumer stocks. The in-line allocation to US equities was also favourable. Conversely, the fund's allocation to Japanese equities hindered relative performance; the shares edged higher but lagged their global peers, dragged down by a stronger yen. In fixed income, sovereign bonds in aggregate underperformed global equities as yields spiked during the first two weeks of January. Even so, the fund's allocation to US Treasury Inflation-Protected Securities and long-dated UK Index-Linked Gilts proved beneficial. The fund's overweight to riskier global high-yield bonds fared much better as performance was supported by tightening spreads. Emerging Market debt also delivered solid returns, mostly aided by a softer US dollar. In alternatives, the allocation to gold delivered solid gains against the backdrop of the ongoing threat of Trump's tariffs. Meanwhile, the trend-following strategy also added value, outperforming sovereign bonds.
