Fund objective

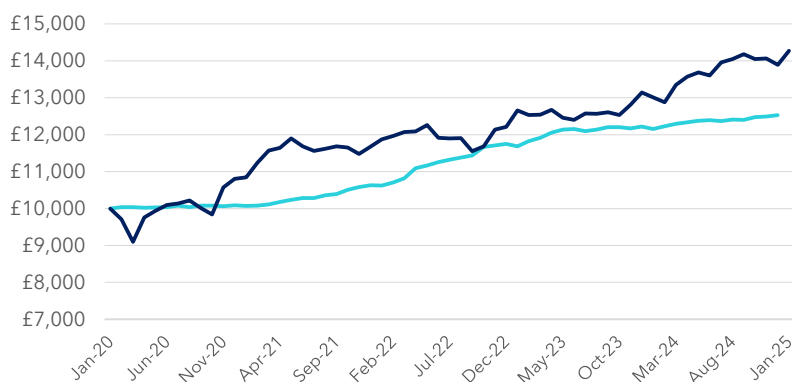
The Fund aims to deliver long term growth over a rolling five-year period in excess of inflation (UK Consumer Price Index).

January Investment Manager commentary

Major stock markets began the year strong. European and UK equities outperformed, driven by a better eurozone outlook and a weaker US dollar. US Treasury yields spiked due to higher inflation expectations from President Trump's policies (including tariffs and tax cuts), but later eased, with sovereign bonds showing modest returns. Elsewhere, gold prices rose.

The True Potential Schrodgers Cautious Fund returned 2.74% (net of fees). The fund's higher allocation to UK equities versus peers proved beneficial. The fund's exposure to emerging markets also boosted relative returns, with the Artemis Global Emerging Markets Fund delivering solid returns for the month. In contrast, the Man GLG Asia (Ex-Japan) Fund edged higher but lagged its peers. Elsewhere, the fund's allocation to gold miners contributed the most to relative returns, with the Schroder ISF Global Gold Fund rising sharply as the gold price was supported by Trump's tariff threats. The fund's exposure to alternatives produced mixed results over the month. The allocations to the Iguana Long/Short Equity Fund and the QSM Global Equity Long/Short Fund fared best, with both gaining over the month. Conversely, exposures to the GLG UK Absolute Value Fund and the GMO Equity Dislocation Fund proved detrimental as both funds posted modest declines. The fund's allocation to fixed income produced modest positive returns but lagged the other segments, with UK Gilts and US Treasuries delivering lacklustre returns as yields spiked during the first two weeks of January.

What is the benchmark for this fund?

The benchmark for this fund is Consumer Price Index (UK CPI). The benchmark may be used as a guide to compare and assess the performance of the Fund. What are the fees associated with investing in this fund?

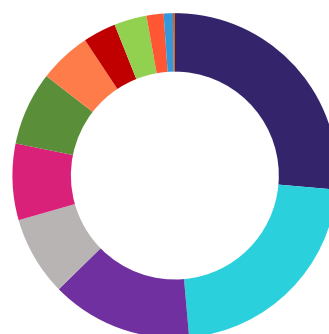
The OCF of this fund is currently 1.17%. This means that if you invest £1000 in the fund, you can expect to pay £11.70 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
