

# True Potential UBS Balanced

## Fund objective

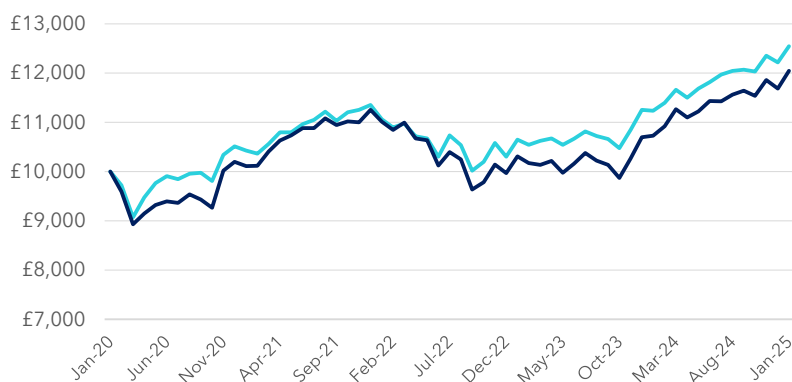
The Fund aims to achieve growth over the long term (5 years or longer) through active management of a diversified investment portfolio whilst seeking to control the overall level of portfolio risk.

## January Investment Manager commentary

Major stock markets began the year strong. European and UK equities outperformed, driven by a better eurozone outlook and a weaker US dollar. US Treasury yields spiked due to higher inflation expectations from President Trump's policies (including tariffs and tax cuts), but later eased, with sovereign bonds showing modest returns. Elsewhere, gold prices rose.

The True Potential UBS Balanced Fund returned 3.08% (net of fees), with the overweight in equities proving beneficial in January. Allocations to index funds that track global equity factors delivered solid returns across the board, with the 'value' and 'momentum' factors performing particularly well. A modest allocation to European equities was another notable contributor; European shares outpaced all their regional peers as positive indicators in the eurozone economy fuelled a rally in financials and consumer stocks. In contrast, the fund's larger allocations to Japanese and emerging market (EM) equities hurt performance, as Japanese shares lagged global peers due to a stronger yen. Meanwhile, EM equities also struggled, mostly due to the ongoing threat of Trump's tariffs and profit taking in Indian shares. The fund's fixed-income holdings had mixed results. US Treasuries and UK Gilts rose slightly, while German and Australian long-duration bonds hurt returns. However, high-yield bonds performed better, benefiting from tightening spreads. EM sovereign bonds also outperformed, mostly aided by a weaker US dollar. In alternatives, gold assets rallied, but the long/short equity hedge delivered only modest gains.

## What are the fees associated with investing in this fund?

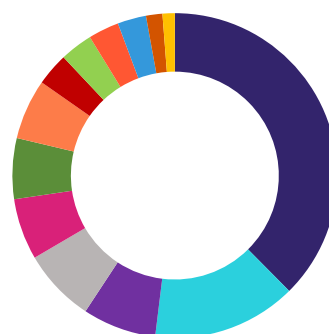
The OCF of this fund is currently 0.59%. This means that if you invest £1000 in the fund, you can expect to pay £5.90 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
